CANADA Proposes New Immigration Class for Low-Skilled

**Bi-weekly Immigration News Breakdown!** 

On August 5, 2024, Immigration, Refugees and Citizenship Canada (IRCC) proposed a significant amendment to the

- Immigration and Refugee Protection Act (IRPA), aiming to introduce a new permanent economic immigration class for low-skilled workers. This proposed class targets individuals with experience and training in TEER (Training, Education, Experience, and
- Responsibilities) levels 4 and 5. TEER 4 includes occupations that require high school education or on-the-job training, while TEER 5 covers roles needing no formal education but short-term work experience.

The new class is intended to address labour market shortages

by broadening immigration pathways for workers in these categories.
