NEWS

- IRCC (Immigration, Refugees and Citizenship Canada) launched an online portal for Designated Learning Institutions (DLIs) to verify International Student's Letters of Acceptance within a 10-day deadline. Failure to validate within the timeframe or a fake LOA leads to the cancellation of a student visa application.
- The Albanese government aims to reduce Net Overseas Migration from 510,000 (2022-23) to 375,000 (2023-24) and further to 250,000 (2024-25), shifting away from "permanent temporariness." This involves promoting pathways to permanent residency and combatting migrant exploitation.
- A new four-year temporary skilled worker visa is introduced, replacing the Temporary Skill Shortage visa, offering three pathways for different skill levels.
- Canada Expands Recognized Employer Program for Faster Foreign Worker Hiring for faster processing and extended Labour Market Impact Assessments (LMIAs) with longer validity and hiring Temporary Foreign Workers in critical 'in-shortage' occupations with a history of at least three positive LMIAs in the past five years.
- Registered Retirement Savings Plan (RRSP) annual percentage of income remains at 18% in 2024.


Shaping Careers Since 2009

- Canada Pension Plan (CPP) contribution increased to \$3,867 annually for those earning at least \$68,500.
- Introduction of the Subclass 192 Pacific Engagement Visa (PEV) for eligible migrants from Pacific countries and Timor Leste, allowing up to 3,000 nationals to migrate to Australia annually.
- 60% increase in 2023 USA visa applications compared to 2022, making Indians one in ten U.S. visa applicants worldwide.
- USA Visitor visas (B1/B2) reached over 700,000 applications in 2023, the second-highest in the U.S. Mission's history.
- Canada Allocates \$86 Million for Foreign Healthcare Credentials and 15 organizations across Canada to receive the funding. Enhancing foreign credential recognition for approximately 6600 internationally educated health professionals (nursing, pharmacy, dentistry, lab technicians, and respiratory therapy).
