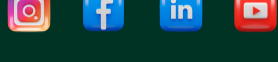

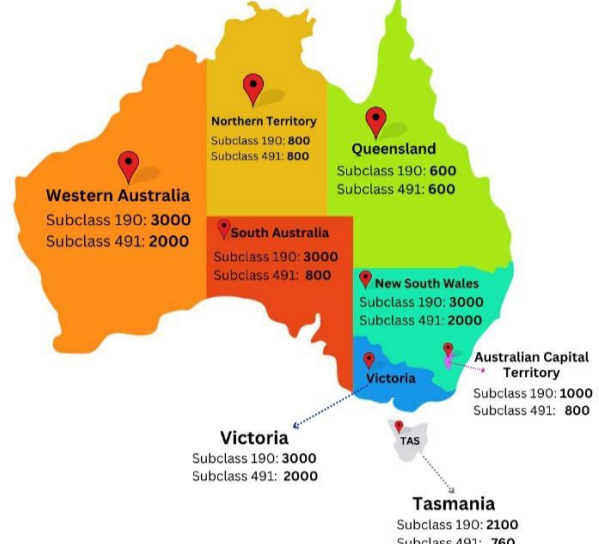

1. Australian Government Released the 2024-25 States Nomination Place Allocation!

The Department of Home Affairs has announced the 2024-25 migration nomination allocation of about 26,260 places for Australian States and Territories.



2. July's EXPRESS ENTRY DRAW brings a game-changing drop in CRS scores, unlocking the gates to CANADA PR opportunities

Canada has issued 1800 Invitations to apply in the latest category-based draw Express Entry Draw to the candidates with French Language proficiency having a minimum 400 CRS score.

3. Australia to implement a New Pre-Application System For Work and Holiday Visas (Subclass 462)!



For the Work and Holiday (subclass 462) visa process the Australian government will open a **new pre-application (ballot) system** for the 2024-25 program year later in 2024 for high-demanding countries including China, Vietnam, and India, with a registration fee set at AUD 25.

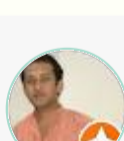
